## ACCOUNTING INSTITUTE IN COLUMBUS, OHIO

The College of Commerce and Administration of The Ohio State University held a very successful Accounting Institute on May 20 and 21. Those fortunate enough to attend were privileged to hear many of the accounting notables of the country including Prof. Clem W. Collins, University of Colorado, President of The American Institute of Accountants, Prof. E. A. Heilman, University of Minnesota, President of the American Accounting Association, Mr. William F. Marsh, President, National Association of Cost Accountants, Hon. George E. Matthews of the Security and Exchange Commission, Howard C. Greer, Institute of American Meat Packers, Victor H. Stempf of Touche, Niven & Company and many others.

Prof. Jacob Taylor, Chairman of the Department of Accounting at The Ohio State University, when remarking about the success of the institute at the banquet, said that the registration was over 400 that night and probably showed an increase on Saturday. Of this number 93 were C.P.A.'s of whom 92 were members of their state societies. Everyone wondered who the lone non-joining C.P.A. was. However, it wasn't a woman because there were only two women C.P.A.'s in attendance and both are members of the Columbus Chapter of C.P.A.'s.

The attendance also included representatives from many states including Kentucky, West Virginia, North Dakota, Minnesota, District of Columbia, New York, Illinois, California and some others.

The representative from California should be particularly interesting to the members receiving this bulletin. This representative was Mrs. Catherine Green who holds a Ph. D. degree in Accounting from the University of California. Mrs. Green is teaching accounting at the University of California at Berkley. She expects to sit for the C.P.A. examination in the near future. After she has passed that barrier, she will be a member of this group, without doubt, because she is very much interested in knowing other women in accounting work.

#### WOMEN C.P.A.'S IN THE NEWS

In a recent issue of "The Face Student" there appeared an article on "Women in Accountancy Practice". Believing that all of our members would be interested we are quoting the article as follows:

"Women have no easy time in breaking into an occupation that has been limited, by custom, to men. Particularly in the professions, such as medicine and law, the pioneers have run into difficulties that would have deterred the faint-hearted. Several years ago, before women were commonly admitted to medical courses, a few medical practitioners who believed it desirable to give women an opportunity to become physicians found it desirable to establish in New York a medical school for women. The Portia Law School in Boston is an outstanding example of a school established for the benefit of women who desire to study law.
