HEIDI M. ALTMAN is Associate Professor of Anthropology at Georgia Southern University. Her specialties include linguistic anthropology, language revitalization and language, and health and worldview.

BOBBY R. BRALY is a Research Assistant and doctoral candidate at the Frank H. McClung Museum, Department of Anthropology, at the University of Tennessee. He is most recently the author, with Shannon R. Koerner and Lynne P. Sullivan, of "A Reassessment of the Chronology of Mound A at Toqua," *Southeastern Archaeology* 30(1), 134-147.

AVI BRISMAN is an adjunct assistant professor at the John Jay College of Criminal Justice, the City University of New York (CUNY), where he teaches criminology and urban sociology. He is also a Ph.D. candidate in the Department of Anthropology at Emory University, where is writing his dissertation on legal consciousness.

JENNIFER CLINTON is the zooarchaeology lab coordinator and an adjunct faculty member in the Department of Sociology and Anthropology at Middle Tennessee State University. Her research interests focus geographically on the southeastern United States and

thematically on general foodways studies, specifically the maintenance of animal related subsistence activities.

JOHN M. COGGESHALL is a Professor of Anthropology in the Department of Sociology and Anthropology at Clemson University, South Carolina. As a cultural anthropologist he is interested in the ways in which people become embedded into landscapes through stories, ownership, occupation, place names, and burials, thus forging a deeply emotional tie to the land. His research focuses on South Carolina's Blue Ridge area.

ERIC GABLE teaches cultural anthropology at the University of Mary Washington. He is the author, with Richard Handler, of *The New History in an Old Museum: Creating the Past at Colonial Williamsburg* (Duke University Press, 1997) and of *Anthropology and Egalitarianism: Ethnographic Encounters from Monticello to Guinea-Bissau* (Indiana University Press, 2011). He is currently a managing editor for *Museum and Society* and book reviews editor for *American Ethnologist*.

LAURA GALKE is an archaeologist for The George Washington Foundation. Her research is contributing to a richer understanding of George Washington's childhood and the role that historical narratives serve in contemporary society. Her published works include analyses of the material culture of 19th-century African American spirituality, of 17th-century European and American Indian contact in the Chesapeake, antebellum college surveillance strategies on the campus of Washington and Lee University, and the mid-18th-century consumer strategies of George Washington's mother.

RICHARD HANDLER is Dean of the Undergraduate College of Arts and Sciences, Professor of Anthropology, and Director of the Program in Global Development Studies at the University of Virginia.

He is a cultural anthropologist who studies modern western societies, with particular interest in nationalism, ethnicity, and the politics of culture. His publications include *Critics Against Culture: Anthropological Observers of Mass Society* (University of Wisconsin Press, 2005); *The New History in an Old Museum: Creating the Past at Colonial Williamsburg*, with Eric Gable (Duke University Press, 1997); and *Nationalism and the Politics of Culture in Quebec* (University of Wisconsin Press, 1988).

MARGARET WILLIAMSON HUBER is Distinguished Professor Emerita at the University of Mary Washington in Fredericksburg, Virginia. Her primary research interests are Native North America, especially the Southeast; Oceania, especially Melanesia; American popular culture; gender; and symbolic systems. Her book, *Powhatan Lords of Life and Death*, was published in 2003 by the University of Nebraska Press.

SHANNON KOERNER is an archaeologist at the Center for Environmental Management of Military Lands at Colorado State University. Her specialties include the prehistoric archaeology of the Southeast. She is the author, most recently, of "A Reassessment of the Chronology of Mound A at Toqua," with Bobby R. Braly and Lynne P. Sullivan, *Southeastern Archaeology* 30(1), 134-147.

VINCENT MELOMO of William Peace University in Raleigh, North Carolina, is an anthropologist who wears several hats. His primary research and teaching interests are in the ethnic diversity of the U.S., with a specific focus on South Asian American youth. However, he also has conducted research in historical archaeology. His contribution to this volume, "The Jamestown Commemoration of 2007: Remembering our Diversity in the Past and Present," marries both these interests.

JENNIFER WILLIAMS NOURSE is Associate Professor of Anthropology and Women, Gender and Sexuality Studies at University of Richmond. She recently completed a Fulbright project on medical anthropology in Indonesia, and she is working on a new book on perceptions of biomedicine in Muslim Indonesia.

TANYA M. PERES is Associate Professor of Anthropology at Middle Tennessee State University. Her research interests are concerned with the relationships between humans and their environments and how these relationships impacted both the humans and other organisms around them in a variety of times and places. She has published widely in such journals as *Historical Archaeology*, *Tennessee Archaeology*, and *Current Research in the Pleistocene*; and she is co-editor, with Amber VanDerwarker, of *Integrating Zooarchaeology and Paleoethnobotany* (Springer Press, 2010).

Doctoral Academy Fellowship. In 2011 Probasco returned to her alma mater, Clemson University, as a visiting lecturer in Anthropology. Probasco's dissertation centering on two communities in the northernmost and southernmost counties of the Arkansas Delta is forthcoming.

LYNNE P. SULLIVAN is Curator of Archaeology at the Frank H. McClung Museum and Adjunct Professor of Anthropology at the University of Tennessee, Knoxville. Her specialties include the prehistoric archaeology of the Southeast and museology. Recent publications include *Mississippian Mortuary Practices: Beyond Hierarchy and the Representationalist Perspective*, edited with Robert C. Mainfort, Jr., Florida Museum of Natural History, Ripley P.
