representatives of Ecuador, Peru and Chile next July 31, probably in Buenos Aires, to press for a solution.

The United States has proposed several times that territorial sea limits be submitted to international arbitration, McCloskey said, but "such offers have been rejected by Ecuador and Peru."

Agreement on a formula for determining territorial limits was narrowly missed at conferences sponsored by the United Nations in 1958 and 1960, he said, but there was general support at both for a 12-mile limit.

The U.S. Navy said it had

made no move in the latest situation to provide protection for fishing boats. Other officials said none of the six U.S.-built warships or patrol craft in the Ecuadorian navy has been used against U.S.-owned vessels.

Pelly said U.S. fishermen had been fined more than \$275,000 since Congress voted in early 1969 to require deduction of the fines from U.S. economic aid, not including the fines levied in the past week.

"Despite the explicitness of this law, the State Department has not made one move to deduct the amount of these illegal fines," he said.

secret ballot. Williams himself, through seniority, will become chairman of the Labor and Public Welfare Committee when Congress reconvenes.

"One possible indication of the worth of seniority system can be deduced from the fact that (it) has not been adopted by any other parliament or legislature in the world," Williams said.

Clarence Mitchell, chief lobbyist for the National Association for the Advancement of Colored People (NAACP), testified that the country has "experienced tragedy, great frustration, divisive turmoil and international embarrassment because of parliamentary pollution.
