September 3, 2013

The first meeting of the University of Mississippi Faculty Senate was called together at 7:02 PM on September 3, 2013.

The following departments were without representation as of this date: English, Leadership and Counseling Education.

The Senate was welcomed by Michael Barnett, as current chair of the Senate. Senator Barnett had advised Provost Stocks that it was not necessary to attend the initial meeting since elections only would occur. Provost Stocks reiterated his willingness to attend but understood the first meeting was to develop the Senate Committees and Officers.

Senator Barnett called for approval for May 2013 minutes, which were moved, seconded and passed without comment.

Senator Barnett gave an abbreviated overview of the mission of the Faculty Senate. He also commented that he hoped the Faculty Senate would be proactive this year with ideas and needs of the faculty, instructors and university rather than waiting for Provost Stocks to bring ideas to the Senate.

Senator Barnett introduced the Election of Officers: (terms 1 year).

Following the call for nominations for Chair of the Senate, Michael Barnett was nominated for a second term as Chair (seconded) and it was moved and seconded that the nominations be closed, and that Michael be approved by full consideration of the Senate. **Senator Michael Barnett** was approved as Chair of the Faculty Senate for 2013-2014 term.

The Chair of the Senate called for the office of Vice Chair of the Senate nominations. **Christian Sellar** was nominated and seconded. Nominations were moved and seconded to be closed and Senator Sellar was approved by acclamation.

The Chair of the Senate called for nominations for the office of Secretary of the Senate. **Carolyn Wiles Higdon** was nominated and seconded. Nominations were moved to be closed, seconded. Nominations were closed and Senator Higdon was approved by acclamation.

Chair Barnett called for Old Business. None was noted.
