Dear Jim:-

I should have long ago acknowledged yours of May 16 and told you and Bill how glad I am that he has been awarded a scholarship at Harvard. Will you give him my hearty congratulations on this recognition of his scholarship?

When he gets up this way I hope he may either visit us here at home or at least that I may see him on one of my rather infrequent visits to Boston and Cambridge. Will you give him our home phone number. It has recently been changed and I can now be reached by calling AXtel (Penna.) 7 - 2426.

While in Chicago a few weeks ago I met a staff representative of the United Steelworkers Union who has charge of the local union at the Chambers Co., in Oxford. As I recall it his name is Emerson Miller. He struck me as a very intelligent, personable fellow and he was very lavish in his praise of you and other folks at the University. His immediate Union superior officer is Philip J. Clowes who has charge of several southern states including Mississippi and whose headquarters are in Tampa, Fla.

Clowes is a fine fellow with whom I used to be associated when I was with the Steelworkers. I have written him about you and I hope this may lead to some arbitration work for you.

I have been taking things somewhat easier this summer. Have been *doing* some consulting work for the Ford Foundation in connection with an Indian engineers training program in the steel industry in this country. About 150 of these people will arrive next month and will work in the steel industry for about one year in addition to getting some on-campus training. Carnegie Tech has charge of the training program. They have all had a good theoretical training but no practical experience. When they complete their work here they will be employed in the new steel mills now being built in India.
