Same as in the past: we let Department Chairs know that they are below the limit (we are doing that now for May and will do it in about a week for Summer Full and Summer 1). That starts a conversation between April and the Chair regarding if the class is needed by student(s). If not needed by students, the Chair and the Dean have the option to help fund a portion of the faculty salary commensurate with the class size (the smaller the class, the larger the funding by the Chair or Dean).

Relevant IHL Policies:

407.02 EVALUATING TEACHING

The method of annually evaluating the quality of teaching may employ multiple sources of data appropriate to the discipline. At a minimum, students enrolled in the course shall have the opportunity to provide written feedback about the faculty member's teaching effectiveness to the faculty member, department chair/head and academic dean.
