Mr. Bostick, born in Bakersfield, California in 1915, and a 1939 graduate of University of California (Berkeley) with a BS degree and membership in Beta Alpha Psi, joined McLaren, Goode, West & Co. in San Francisco in 1945. He was in their New York office at the time of the merger in 1952, became a principal at that time, and returned to San Francisco in 1955. From 1958 to 1960 he practiced in San Diego with another CPA and then rejoined H&S as a principal in our office there.
