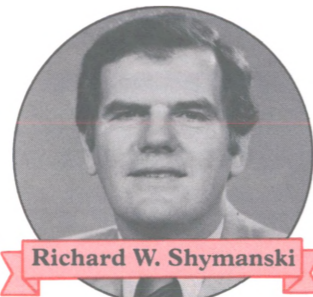
Walter A. Stosch
