The AICPA Public Service Committee encourages CPAs to participate in activities that will benefit their communities. The committee answers this challenge through several activities and develops public service programs for use by the AICPA, state societies and individual members.

Public Service Award Program – The AICPA nationally recognizes CPAs honored by their state societies with Public Service Awards. The award is given by each state society to a CPA who has distinguished himself or herself in public service activities. The AICPA annually recognizes the state award winners with a reception held in their honor at the Annual Meeting where each award winner receives a commemorative framed certificate. In addition, an advertisement featuring the names and photographs of the 1990 winners will appear in the *Journal of Accountancy*. This year, 47 state societies participated in this program.

Directory of Volunteer Accounting Programs – This year, through a grant from the AICPA Public Service Committee, Accountants for the Public Interest (API) will compile the second edition of the National Directory of Volunteer Accounting Programs. The directory lists CPAs who willingly share their knowledge and expertise with organizations who need help but cannot afford it. Over 200 programs in 45 states are included in the directory.

National Volunteer Week – The AICPA Public Service Committee will participate in National Volunteer Week 1991 by developing an informational program and brochure. The brochure outlines possible deductions for people who donate time, services or possessions to charitable organizations. A promotional kit with copies of the brochure, sample speeches and radio public service announcements will be sent to societies to enable them to participate in National Volunteer Week.
