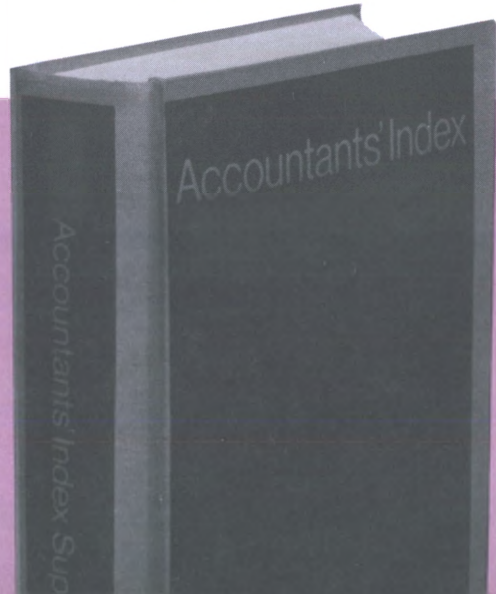

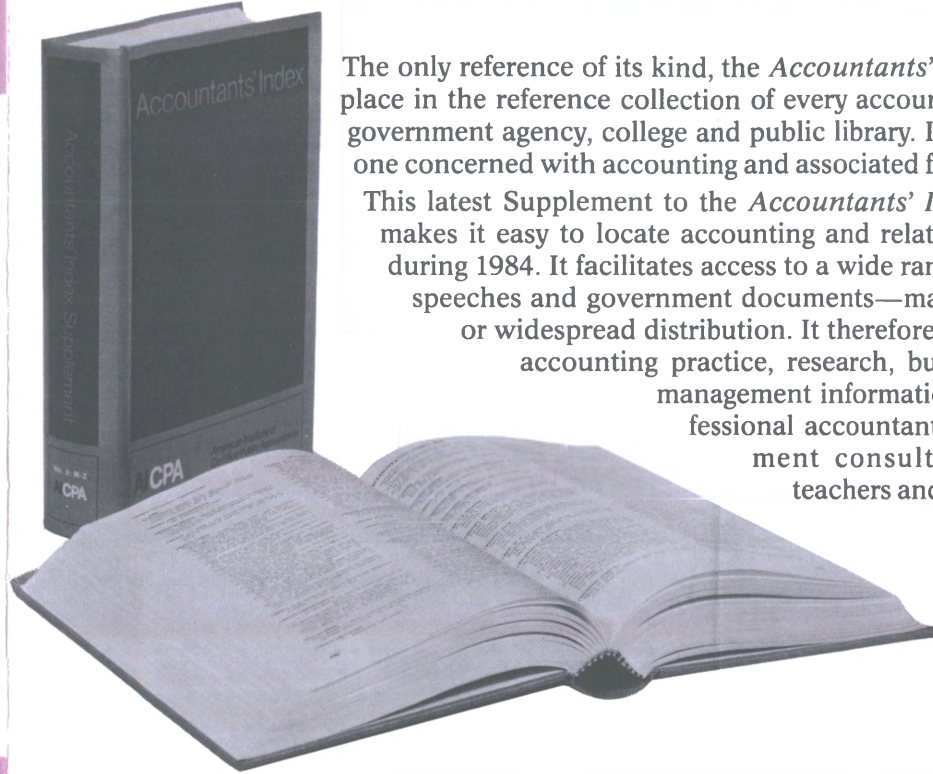

This important study examines the nature, extent and costs of the procedures used by auditors in complying with current standards for reporting the effects of changing prices.
