AUTHORS OF ARTICLES IN THIS ISSUE

ERIC A. CAMMAN, author of "Relation of Costs to the Determination of Selling Prices," is a partner of Peat, Marwick, Mitchell & Co., New York, N. Y. Mr. Camman received his higher education from Columbia University, and, after a varied commercial experience, entered the field of public accountancy. He is a member of the New York State Society and the New Jersey Society of Certified Public Accountants. Mr. Camman was a charter member of the National Association of Cost Accountants and served the association in many capacities for a number of years—as president of the New York chapter, member of the national board, director in charge of research, director in charge of chapters, vice-president, and, in 1934–1935, as president. He has been a member of the American Institute of Accountants since 1929, and has served on several of its committees, including the committee on nominations and the committee on budget and finance (as chairman). He also served on the special committees on public relations, cooperation with N.R.A., and development of practice. Mr. Camman is the author of many articles on cost accounting subjects and of the book, *Basic Standard Costs*, published by the American Institute Publishing Co., Inc.

GEORGE O. MAY, author of "Recent Opinions on Dealings in Treasury Stock," has been a frequent contributor to THE JOURNAL OF ACCOUNTANCY. He is a certified public accountant and is senior partner in the firm of Price, Waterhouse & Co., New York, N. Y. Mr. May is a member of the American Institute of Accountants and at present is chairman of the Institute's committee on accounting procedure.

VICTOR H. STEMPEF, author of "Significant Changes in Federal Income Taxation," studied at the School of Commerce of St. Louis University and after graduation taught auditing and accounting there from 1919 to 1923.
