HR has received several inquiries regarding the Institute's Business Casual Dress Code. Below is a list clarifying what is and isn't appropriate:

Neat, clean, pressed and wrinkle-free clothing	Excessively worn or faded clothing with holes or frayed areas
 Loafers, boots, flats, dress sandals and leather deck shoes Clean jeans and cotton slacks 	 Athletic shoes, sneakers and slippers Sweatpants, shorts, bib overalls, spandex, lycra and other form-fitting pants and jeans
 Casual shirts, golf shirts, sweaters and turtlenecks Causal dresses and skirts; skirt lengths should be appropriate for an office environment 	 T-shirts, tank tops, shirts with inappropriate messages/graphics, and tops with bare shoulders (unless worn under a blouse/shirt or jacket) Spaghetti-strap dresses/blouses Anything you might wear to the gym, to the beach or to clean around the house

FACT AND FICTION ABOUT LAST WEEK'S NY OFFICE "BOMB SCARE"

On Tuesday, April 28, rumors circulated throughout the Institute that the NY office experienced a bomb threat in its building. We wanted to take this opportunity to clear the air and separate fact from fiction regarding this incident.

On April 28, 1998, a suspicious-looking package arrived at the main mail center that services all tenants of the 1211 Avenue of the Americas building, located on the ground floor. The package was not addressed to anyone at AICPA, but another tenant of the building located on the 37th floor. Mail center personnel alerted Rockefeller Center building security, who agreed that the package looked suspicious but determined that it was not necessary to alarm any of the tenants. Accordingly, no tenants were evacuated. As a precaution, building security personnel sealed off access to the 47th street side of the building (where the mail center is located) so the package could be further inspected. Within the hour, building security determined that the package did not contain a bomb, but was in fact a hoax, and business-as-usual soon resumed.

Joe Ciccone, Administrator of Facilities Management in the New York office, further noted that if at any time any of the AICPA buildings experience a building emergency, information and instructions would be given over the office's PA system. In this case, Rockefeller Center building security determined that no tenants were in danger, and accordingly, no public announcement was made to New York AICPA employees or any other tenants.
