Parking Options Alternative parking is just around the corner! Two parking lots are located just a block or two away from the Harborside Financial Center.

For commuters who enjoy a little morning and afternoon exercise, an outdoor parking lot is located northwest of the Harborside parking lot on Washington Street (off Christopher Columbus Drive). The parking lot does not have a name but can be identified by a sign that says "Parking - \$6.00 All Day." This parking area is offering a discounted monthly parking rate **beginning September 1st** of \$80 per month. **This offer is valid for AICPA employees only.** An attendant is present from 7:00 a.m. - 7:00 p.m. The daily parking rate is \$6.00. If interested, see the attendant on September 1st, show him your AICPA I.D. and pay \$80.00 by cash or personal check and he will give you a sticker for your car.

Indoor garage parking is also available at the Edison Park Fast located at 101 Hudson Street with the garage entrance on York Street. Edison Park Fast is two blocks from the Exchange Place PATH station and the monthly fee \$129.00. The garage is fully attended and open from 6:00 a.m. - 12:00 p.m. Coupons will be available sometime this week for \$10.00 off your first month's fee and \$1.00 off for daily parking. Dental Plan Reminders

For those employees who enrolled in the DMO, don't forget that as of September 1st, you and your covered dependent(s) must be treated by your DMO dentist in order to receive maximum coverage under the plan. Also, you should receive ID cards for yourself and, if applicable, your dependent(s) by mid-September. If you need to make a dental appointment before you receive your I.D. card - just mention that you are a DMO member and the dentist can then verify your coverage directly through Prudential.

All employees have the option of switching from the traditional plan to the DMO or vice versa at the beginning of any month, as long as you call the DMO hotline (1-800-THE-DMO1) by the 15th of the previous month. You can also call the DMO hotline to switch dentists or request up-to-date information on participating dentists.
