Nonsolicitation

Recently, several staff members reported that an outside vendor has been canvassing them for their business. The solicited employees were rather annoyed especially when the vendor requested to meet with them during regular business hours.

The Institute does not condone solicitation by nonemployees or employees. The AICPA nonsolicitation policy, which can be found on page 11 of the Employee Handbook, is reproduced below. Please take a few minutes to reacquaint yourself with the policy and if you experience any violations to the policy, contact Pat Duane in Human Resources on x6203.

It is our objective to provide a comfortable work environment which allows staff members to complete their tasks with the least amount of interruptions or disruptions. Accordingly, the AICPA has established the following policy:

- Nonemployees are not allowed at any time to come upon our premises for the purpose of any form of solicitation or literature distribution. This policy is to restrain third parties or strangers from soliciting or handing out materials for political, union, charitable, or similar activities.

- Employees are prohibited from distributing any form of literature or other materials in their work area. Employees are also prohibited from soliciting for any cause during their assigned working time or soliciting other employees during their assigned working time. These prohibitions on employee solicitation and literature distribution do not apply during employees' nonworking time such as lunch periods or coffee breaks.
