**To Change or
Add Medical
Coverage**

Employees may take the opportunity to change their medical coverage effective September 1, 1994 from US Healthcare to PruCare or vice versa.

If you are not currently enrolled for medical coverage under PruCare or US Healthcare, you may either enroll in the US Healthcare plan by completing the necessary enrollment form, or you may apply for coverage under the PruCare Plus plan by submitting a medical evidence of insurability application for yourself and each eligible dependent you wish to cover.

US Healthcare covered employees and their dependents are eligible to switch to the PruCare Plus plan by simply submitting a completed enrollment form. (The same process is available for employees and their dependents who switch from PruCare to US Healthcare).

The information packages, which include the provider directories and the necessary enrollment forms for both plans, are available in Human Resources. If you wish to change your medical plan, you must complete and return the enrollment form (and the evidence of insurability form, if applicable) to Human Resources - New Jersey by **5:00 p.m. Friday, August 26, 1994.**
