To Celebrate the 500th Anniversary of the Publishing of Luca Pacioli's "Summa" including double-entry bookkeeping (Answers will appear in next week's edition of Inside.)

1.	Luca Pacioli was born in 1445 in a small town in Italy called Borgo San Sepulcro, which is about 80 miles east of what major Italian city?
2.	Pacioli was a member of a religious order of monks. To what order of monks did Pacioli belong?
3.	Pacioli's "Summa" was published in Italian, even though was the language of the educated at that time.
4.	What was Pacioli's relationship to Leonardo da Vinci?
5.	What would be the English translation for the title of Pacioli's work: Summa do Arithmetica, Geometria, Proportioni et Proportionality.
6.	Very few words in the English language contain three double letters in a row. One of those words is significant in the context of Luca Pacioli. What is that word?
7.	What standard-setting group is the predecessor to the Financial Accounting Standards Board?
8.	If the debits are near the door, what are the credits near?
9.	What is the AICPA's match to employee contributions to their 401(K) plan accounts?
10.	April 15 is commonly known as the tax-filing deadline; however, a taxpayer may have an extension until just for the asking (Form 4868).
11.	In 1974 the title of the chief executive of the Institute became "President" and the title of the volunteer leader became "Chairman (sic) of the Board." Who was the first person to hold the title of Chairman of the Board of the AICPA?
12.	In what year was the name of our organization changed to "American Institute of Certified Public Accountants?" and what is the name it was changed from?
13.	When was the Journal of Accountancy first published?
14.	What state passed the first CPA law, and in what year?
15.	Prior to moving to the Avenue of the Americas in 1974, what was the address of the AICPA's headquarters?
16.	In the summer of 1992, the majority of the AICPA's operations was moved to the Harborside Financial Center complex in Jersey City, NJ. How many staff members are employed at that location full-time?
17.	On average, how many calls does the Technical Information Hotline receive in a year?
18.	How many AICPA cost centers do we have?

19. Including Phil Chenok, how many staff chief executives has the Institute had in its 107 year history?

20. Which employee has been with the AICPA the longest?
