AUTHORS OF ARTICLES IN THIS ISSUE

HARVEY C. DAINES, author of "Theory and Procedure for Pooled Investments in Colleges and Universities," is at present controller of the University of Chicago. He received his A.B. and B.C.S. degrees from Albion College and his M.A. degree from the University of Chicago. Mr. Daines was formerly associate professor of accounting in the school of business of the University of Chicago, dean of the Central Y.M.C.A. College of Commerce, and director of Central Y.M.C.A. College, in Chicago. He also has been an income-tax auditor in the Internal Revenue Bureau and a consultant on problems of organization and management for business concerns. Mr. Daines is a certified public accountant of Illinois and Wisconsin, and has been a member of the American Institute of Accountants since 1926.
